H&P (including clarification of diagnosis)

Recent BUN and Creatinine results

Supporting diagnostic test results (including EMG, nerve conduction

test, muscle biopsy [if available], nerve biopsy [if available])

MRI of nerve roots (if available)

CSF examination (if available)

Previous treatment(s) and clinical outcomes for each

Adverse side effects from previous treatments
